

**MEMORANDUM
OF COLLABORATION AND COOPERATION
between
MUNICIPAL INSTITUTION OF HIGHER EDUCATION
"KHORTYTSIA NATIONAL EDUCATIONAL REHABILITATION ACADEMY"
OF ZAPORIZHZHIA REGIONAL COUNCIL
and
EUROPEAN INSTITUTE FOR CULTURAL TOURISM "EUREKA",
DOBRICH, BULGARIA**

Municipal Institution of Higher Education "Khortytsia National Educational Rehabilitation Academy" of Zaporizhzhia Regional Council, represented by the Rector, Doctor of Pedagogical Sciences, Associate Professor Valentyna Nechyporenko, acting under the Charter, and European Institute for Cultural Tourism "EUREKA", represented by the Director, Doct. Geography of Recreation and Tourism Krasen Rusev Sabev, acting under the Charter, hereinafter referred to as the "Parties", focus for building and developing the close cooperation between the Parties, based on the mutual benefits in the research and educational collaboration, hereby agreed as follows:

1. The Parties has composed this Memorandum with the main aims of encouraging the joint research work and educational collaboration, providing exchange for professors and students as well as determining the directions for cooperation. In this context both institutions will endeavor:

- to provide exchange for professors and students;
- to organize joint scientific and theoretical conferences, including on-line conferences, seminars, forums, symposia;
- to develop the close cooperation between the faculties and departments;
- to enable joint research studies;
- to interexchange and work together to prepare research-educational programs, textbooks and manuals;
- to share scientific information and scientific publications;
- to interchange periodicals, journals and other scientific sources of specified fields;
- to publish scientific research articles;
- to invite each other to participate in international projects, grants and programs initiated by one of the Parties;
- to provide on-the-job training for the students at the host institution;
- to promote undergoing work practice for the students at the host institution;
- to facilitate mutual assistance in developing teaching staff;
- to provide exchange of experience in developing advanced educational methods;
- to set up joint summer schools and to hold other events;
- to provide exchange of experience in educational and research management;
- to provide information on the work of the two educational institutions to the academic community.

2. The Parties may collaborate in other new ways. Directions of collaboration are to be revised and adjusted by the Parties, as appropriate.

3. The Parties undertake to maintain functional relationship and do what is necessary to improve business dealings, encourage other forms of cooperation for achieving the goals of the Memorandum referred to in paragraph 1 above.

4. The Parties agree to collaborate in the order acceptable to both sides.
5. The Parties separately determine that signing of this Memorandum does not impose any financial obligations on the signatories. Separate agreements should be concluded, if necessary.
6. The Parties cooperate to implement the points of this Memorandum through the authorized officials delegated by the Parties to discuss emerging issues and to carry out joint actions:
 - Khortytsia National Academy delegates;
 - European Institute For Cultural Tourism EUREKA delegates.
7. Under the Memorandum, the Parties shall be governed by national law that is effective in their countries and they will cooperate on the basis of equality, openness and integrity.
8. The Parties agree that the terms of this Memorandum are not confidential and could be provided to concerned third parties, if necessary.
9. Any disputes or disagreements, arising out of or in connection with this Memorandum, should be settled by negotiations or consultations between the Parties.
10. Amendments and additions to this Memorandum must be in writing, signed by the appropriate officials of the Parties and they are an integral part of this Memorandum.
11. This Memorandum will be considered valid for five (5) years once signed by each Party. The Memorandum will be extended for another five years unless one of the Parties notices of the intention to terminate it. Requests for withdrawal from the Memorandum must be in writing. This notification must be given at least one (1) month prior to the termination of the five (5) year program.
12. The Memorandum could be cancelled unilaterally. This notification must be given in writing at least thirty (30) days prior to its cancellation.
13. The present Memorandum is drawn up in two copies, one in the Ukrainian and one in the English language, one copy for each Party. Should there be any inconsistencies or discrepancies in the use of the terms, the Memorandum in Ukrainian would prevail.
